Re: Declining Representation of I Viewit Technologies, Inc.

Dear Eliot:

This letter responds to your August 2, 2003 email letter to me. Please be advised that Christopher & Weisberg, P.A. is declining to represent I Viewit Technologies, Inc. (Iviewit).

As an initial matter, we note that the decision as to whether to represent a client is one made by both the client and the lawyer. Although we are flattered by your interest in retaining our Firm, we have decided not to represent Iviewit. Christopher & Weisberg has never agreed to represent Iviewit, has not undertaken any actions or performed any acts on behalf of Iviewit, has not received an executed written Engagement Agreement from Iviewit and has not received any advance retainer. It is the policy of Christopher & Weisberg, P.A. not to undertake representation of a client in the absence of (1) an executed Christopher & Weisberg, P.A. Engagement Agreement and (2) an agreed to and received advance cash retainer. Regardless of any subsequent receipt of the latter, Christopher & Weisberg does not wish to represent Iviewit.

We are not privy to any agreements or arrangements you may or may not have had with Schiffrin & Barroway. We do not wish to get involved in any disputes or contract issues you may have with that or any other law firm, and ask that you kindly respect our wishes to stay removed from these disputes.

We have not substantively reviewed the copies of the files we received from Blakely, Sokoloff and have no plans to do so. We are not retaining these copies and are returning all copies to Blakely, Sokoloff today, August 4, 2003, via overnight courier.
